### **Short Term**

Substantive financial compensation for victims and their families

## AMMENDMENT OF EDUCATION ACT

to protect children from denial of admittance to any educational institution or discrimination on the basis of culture or religion including wearing locks or other natural or African-centered hairstyle

#### **OMNIBUS LEGISLATION**

## Human & Indigenous Rights Protection Act

Public Bill of the Supreme Court to make it a criminal offence for any violation of the Human and Indigenous groups including RasTafari, Maroons and other African-centered groups and practices in

#### **RESTORATIVE JUSTICE**

for the empowerment and development of Rastafari community and community-based initiatives:

- **a)** Tax exemption for large scale Rastafari grassroots ganja initiatives
- **b)** Legislative allocation of a portion of license fees for Rastafari ganja projects
- c) Designation of Government Crown lands across the country for Rastafari agricultural and other development initiatives
